RESPONSES TO THE 2015-2016 LOS ANGELES COUNTY CIVIL GRAND JURY **FINAL REPORT**

Pursuant to Section 933(c) of the California Penal Code, the County intends to provide a single, coordinated response (including those from elected department heads) to Civil Grand Jury (CGJ) recommendations, no later than 60 days after the submitted CGJ final report on the operations of any public agency subject to its reviewing authority. Consistent with this provision, we are requesting responses from your department to those recommendations pertaining to your operations. The Chief Executive Office (CEO) will compile the responses and place them on the Board's agenda on Tuesday, August 23, 2016. A copy of this memorandum, attachments, and an electronic version of the response template will be e-mailed to your Administrative Deputy shortly. If you do not have a hard copy of the 2015-2016 Civil Grand Jury Final Report, you may access it at the Grand Jury's Website:

Please note following:

- Based on the timeframe discussed above, <u>responses are due to the CEO no later than Friday</u>, <u>July 22</u>, <u>2016</u>. This will allow time for the CEO to compile the responses and prepare draft Board letter for Board deputies' review by the beginning of August, brief the Board deputies, file the final Board letter by August 11, 2016, and place the matter on the August 23, 2016 Board Agenda, prior to expiration of the 60-day deadline.
- Elected officials (Sheriff) and direct reports to the Board of Supervisors (Probation)
 need to provide their original response to the CEO with a cover letter on
 departmental letterhead, addressed to the Board of Supervisors and signed by
 the elected official or department head.
- All other departments will need to provide their original responses with a cover letter on departmental letterhead, addressed to the CEO and signed by the department head.
- Attachment A provides information indicating the lead department/agency for each audit area. If your department has more than one audit section mentioned, please submit a separate response for each section.
- Attachment B provides instructions on how to respond to the recommendations.
- Attachment C provides the response template, containing department name, audit section title, recommendation number, along with the department's response.
- In addition to the original cover letter and response(s), please email an **electronic copy** of the cover letter, in PDF format, and the department's response(s), in MS WORD format, to the address identified below.

HOW TO RESPOND TO EACH RECOMMENDATION

Pursuant to California Penal Code §933.05, the department responding to each grand jury finding shall **FIRST** <u>indicate one of the following</u>:

- 1. The respondent agrees with the finding; **OR**
- 2. The respondent disagrees wholly with or partially with the finding, in which case the response shall specify the portion of the finding that is disputed and shall include an explanation of the reasons therefore.

SECOND, the department responding to each grand jury recommendation shall <u>report</u> one of the following actions:

- 1. The recommendation has been implemented, with a summary regarding the implementation action; **OR**
- 2. The recommendation has not yet been implemented, but will be implemented in the future, with a timeframe for implementation; **OR**
- 3. The recommendation requires further analysis, with an explanation and the scope and parameters of an analysis or study, and a timeframe for the matter to be prepared for discussion by the officer or head of the agency or department being investigated or reviewed, including the governing body of the public agency where applicable. This timeframe shall not exceed six months from the date of publication of the grand jury report; OR
- 4. The recommendation will not be implemented because it is not warranted or is not reasonable, with an explanation therefore.
